## INVITATION TO BID FOR THE SUPPLY AND REHABILITATION OF THE DAMAGED FACILITIES OF THE COLLEGE

- 1. The BATANES STATE COLLEGE, through SARO-ROII-17-00042193 intends to apply the sum of TWO MILLION FIVE HUNDRED SIX THOUSAND TWO HUNDRED FIFTY & 00/100 PESOS ONLY (Php2,506,250.00) being the Approved Budget for the Contract (ABC) to payments under the contract for THE SUPPLY AND REHABILITATION OF THE DAMAGED FACILITIES OF THE COLLEGE/IAEB#17-005. Bids received in excess of the ABC shall be automatically rejected at bid pening.
- 2. The BATANES STATE COLLEGE now invites bids for THE SUPPLY AND REHABILITATION OF THE DAMAGED FACILITIES OF THE COLLEGE/IAEB#17-005.<sup>4</sup> Delivery of the Goods is required within THIRTY (30) calendar days upon receipt of Purchase Order or Notice to Proceed. Bidders should have completed, within FIVE (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- Interested bidders may obtain further information from BATANES STATE COLLEGE
  and inspect the Bidding Documents at the address given below during office hours, from
  Monday to Friday.
- A complete set of Bidding Documents may be purchased by interested Bidders on August 10, 2017 from the address below and upon payment of a nonrefundable fee for the

- Bidding Documents in the amount of FIVE THOUSAND & 00/100 PESOS ONLY (Php5,000.00).
- 7. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
- The BATANES STATE COLLEGE will hold a Pre-Bid Conference on August 17, 2017, 10:00AM at the Bids & Awards Committee (BAC) room, Batanes State College, which shall be open to all interested parties.
- Bids must be delivered to the address below on or before August 29, 2017 at 10 AM. All
  Bids must be accompanied by a bid security in any of the acceptable forms and in the
  amount stated in ITB Clause 18.
- 10. Bid opening shall be on August 29, 2017, 10 AM at Bids & Awards Committee (BAC) room, Batanes State College. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 11. The BATANES STATE COLLEGE regrets to inform the prospective On-line Bidders that Electronic Bidding as provided for in Government Procurement Policy Board (GPPB) Resolution No. 23-2013 is hereby temporarily suspended pending to PhilGEPS trainings for the operation of the system by the members of the Bids and Awards Committee (BAC).
- 12. The BATANES STATE COLLEGE reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
